Contract of Services

We (A Family Dog) agree to exercise due and reasonable care of your animal and to provide your animal with safe quarters and to properly feed and care for your animal. All animals are kept and trained or otherwise handled or cared for by us without liability on our part for loss or damage from disease, death, running away, theft, fire, injury to persons, other dogs, or property by said animal or other unavoidable causes due to diligence and care having been exercised. If the animal's health demands action, A Family Dog Obedience is hereby authorized to have a veterinarian authorize and/or look at and treat the animal for the care needed. Owner hereby authorizes information acquired during treatment to be released to A Family Dog. The owner shall assume full financial liability in such instances. Owner further authorizes A Family Dog to administer aspirin, anti-histamine or flea medication should there be a need unless specified instructions from owner state otherwise.

Owner agrees to pay the rate for training/boarding in effect on the date of check-in, payable, in full upon pick-up of dog. Owner further agrees that the dog remain in the care of A Family Dog until all charges are paid in full. A Family Dog shall have and is hereby granted a lien on the dog for any and all unpaid charges resulting from the care of dog at A Family Dog.

It is expressly agreed by Owner and A Family Dog that A Family Dog's liability shall in no event exceed the lesser of the current chattel value of a dog of the same species of the sum of \$500.00 per animal boarded and/or trained. Owner further agrees to be solely responsible for any and all acts or behaviors of said dog while it is in the care of A Family Dog.

By signing this Contract and leaving his/her dog in our care, owner certifies to the accuracy of all information given about said dog. Any controversy or claim arising out of, or relating to this contract, or breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled in any Court having jurisdiction therein or by any legal arbitrator having legal right to do so. The arbitrator shall, as part of his/her award, determine and award to the prevailing party of the cost of such arbitration and reasonable attorney fees of the prevailing party. This Contract contains the entire agreement between the parties. All terms and conditions of the contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and of A Family Dog.
